Sec. 17-1. Street or Sidewalk Obstructions.

It shall be unlawful for any person to encumber or obstruct a street or sidewalk with merchandise, lumber, wagons or vehicles of any kind for a longer time than necessary. (Fort Deposit Code, 1906, Chap. 6, Sec. 166; Code of Alabama, Tit. 37, Sec. 647 et seq.)

Sec. 17-2. Obstructions to Streets and Sidewalks.

It shall be unlawful for any person to obstruct any street or sidewalk with any animal or vehicle, or with boxes or barrels or other like commodity, or standing thereon so as to obstruct the free passage of persons on such street or sidewalk. (Code of Fort Deposit, 1906, Chap. 13, Sec. 278.)

Sec. 17-3. Erecting Structures that will Obstruct Streets or Sidewalks - Penalty For.

It shall be unlawful for any person, without the permission of the Council, to erect or enlarge a building or extend a fence so as to encroach upon the street or sidewalk. (Code of Fort Deposit, 1906, Chap. 6, Sec. 167.)

Sec. 17-4. Sidewalk - Right of Way.

It shall be the duty of all persons passing or meeting each other on any sidewalk in the Town to give each to the other one half of said sidewalk, so as to allow sufficient room to pass each other without jostling or giving inconvenience to the person passing. (Code of Fort Deposit, 1906, Chap. 6, Sec. 168.)

Sec. 17-5. Sidewalk - Riding and Driving on Sidewalks.

It shall be unlawful for any person to ride or drive on any sidewalk in the Town. (Code of Fort Deposit, 1906, Chap. 13, Sec. 238.)

Sec. 17-6. Sidewalk - Throwing Articles onto Streets and Sidewalks.

It shall be unlawful for any person to throw any article from the roof or upper store of a house upon any street or sidewalk. (Code of Fort Deposit, 1906, Chap. 13, Sec. 251.)

Sec. 17-7. Fresh Meats and Fish - Sale on Sidewalks or Streets Prohibited.

It shall be unlawful for any person to store, sell or offer for sale on any sidewalk or street in the Town of Fort Deposit, any fresh beef, pork or other fresh meats or fresh fish. (Ord. of 7 June, 1906.)

Sec. 17-8. Obstructing Ditches, Culverts - Penalty For.

It shall be unlawful for any person to willfully fill up or otherwise obstruct any ditch, culvert or natural water outlet on any of the streets, alleys or highways in the Town of Fort Deposit, or to cut or remove or otherwise damage, any dam or embankment, natural or artificial or to remove from any such dam or embankment, any brush, timber, dirt, wood or lumber, or remove any timber or lumber from any bridge, culvert or other structure, built or erected on the streets, alleys or highways in the Town of Fort Deposit for the improvement of such streets, alleys or highways. (Code of Fort Deposit, 1906, Chap. 6, Sec. 178-179.)

Sec. 17-9. Regulation of Utility Rights of Way on State  
Roads.

The Town of Fort Deposit shall adhere to the "Standards Accommodating Utilities on State Highway Rights of Way" as promulgated by the State of Alabama. (Ord. of 10 Jan., 1972.)
